

This Professional Advice User Agreement ("**User Agreement**") is a contract between you and Psychology.com, Incorporated and applies to your use of the Professional Advice Services. As a Professional Advice User, you are requesting access to the site and services only under the policies, terms and conditions below. The policies, terms and conditions below limit Psychology.com's liability and obligations to you and allow Psychology.com to change, suspend or terminate your access to and use of the Site and Advice Services. We urge you to carefully read the following terms and conditions, and all policies referenced below or elsewhere on the Site.

YOU UNDERSTAND THAT BY CLICKING THE BUTTON TO CONTINUE ON THE REGISTRATION PAGE, BY USING THE SITE AND ANY ADVICE SERVICES INCLUDING ANY CONTENT PROVIDED THEREIN, BY INITIATING ANY FORM OF COMMUNICATION WITH A THERAPIST OR BY POSTING ANY LISTINGS ON THIS SITE, YOU ARE AGREEING TO BE BOUND BY THIS USER AGREEMENT THAT BINDS YOU IN THE SAME WAY THAT A PAPER CONTRACT BINDS YOU. ALL USE OF THE SITE AND ADVICE SERVICES IS SUBJECT TO THE TERMS OF THIS USER AGREEMENT AND THE POLICIES, TERMS AND INSTRUCTIONS REFERENCED IN THE SITE, WHICH ARE INCORPORATED AND CONSIDERED AS PART OF THESE TERMS.
